# Application for tax exemption submitted

We have submitted our application for taxexemption to the IRS! A huge thanks to Rus McCracken and Alan Wynn for leading the effort to become a tax-exempt 501(c)(7) social club. They spent time researching, contemplating, and consulting with AOPA to make sure that our application was complete and thorough so that we have our best chance of being approved. Their guidance drove the refinements to our Bylaws and Membership Flight Rules so that it is clear that we meet the latest IRS rules. The Board has viewed our long-held goal of becoming tax-exempt as key to keeping our costs low as we prepare to purchase the hangars and future engine replacements and aircraft upgrades. The IRS recognizes the importance of social clubs, and the Board believes our club meets the requirements to be tax-exempt.

I wanted to share Rus's introduction paragraph that leads into the club activities section of the application:

Blue Sky Pilots, Inc. provides an opportunity and venue for club members to experience the pleasure of general aviation flying, education, and advocacy while making social connections. Membership in the club is open to pilots and those interested in pursuing general aviation. The operation and overall design of the club is to provide significant opportunities for membership interaction encouraging social gathering, sharing of aviation experiences, and Additionally, camaraderie. the club offers opportunities for members to improve their aviation skills.

Some members might have reduced or paused their flying over winter, and if that includes you, please think about your currency and proficiency before your next flight.

In addition to the FAA's currency requirements, the club also has insurance requirements that we all need to follow. Please take a moment to refresh yourself on the Currency section of the <u>Membership</u> <u>Flight Rules</u>. The key items are:

- Every 12 months, a club flight review with a club instructor
- Every 90 days, act as PIC of an aircraft
- Every 90 days, complete three landings in category and class

Please also remember that current isn't the same as proficient, and if you have any questions or concerns about operating the club aircraft safely, any club instructor can help you with checkouts or refresher flights.

#### Lightspeed headsets tip

We've heard from multiple members with Lightspeed headsets that they've had audio issues in some of the club aircraft. Things like the sound breaking up, or hearing nothing at all. Lightspeed helpfully offered the club some spacers to adjust how the headset plugs fit into the aircraft sockets, although that doesn't always seem to help.

If you've experienced this issue, you can also try setting your headset from mono – which is the factory default setting – to stereo. That has resolved the issues for at least some members. All the club aircraft have stereo audio panels so there shouldn't be any issue with moving between them.

Check your user's manual for instructions on how to switch from mono to stereo; it's most likely a DIP switch inside the battery holder.

#### **PIREP: Swell café at Siletz Bay**

## PIREP: 2024 Buckeye Air Fair & AOPA Fly-in Recap Mikel Wynn

From February 15 to the 19th, I took time off work and flew commercial down to Mesa, Arizona to visit my dad and sister, who were down there and check out the place the home where my parents will eventually relocate to as part of their retirement. This trip also coincided with the 2024 Buckeye Air Fair & AOPA Fly-in, which took place February 16-18 at the Buckeye Municipal Airport (KBXK/BXK) just west of the Phoenix-area. This trip allowed me to get an unexpected, yet welcome early start to my 2024 air show season!



Once I knew I was going to be in the Phoenix-area for sure and as a current member of the Aircraft Owners & Pilots Association (AOPA), I RSVP'd for the fly-in event via the AOPA website (more on that later!). A little background on this event: the Buckeye Air Fair started out as a simple fly-in pancake breakfast and airport open-house-style event in the early 2000s. Over the years, the event evolved into a convention-style aircraft display where aircraft manufacturers and aviation companies bring and show off their products; the occasional military flyover was added during some years as well, pending availability. Then, in 2023, full air show performances were added to the event for the first

time; according to AOPA, over 500 aircraft flew in, and more than 30,000 spectators participated for the 2023 Buckeye Air Fair & AOPA Fly-in. For 2024, the turnout was forecasted to be bigger than last year and based on what I saw and experienced, I think it's safe to say this was another successful year for AOPA and the city of Buckeye.

The performer line-up for the 2024 Buckeye Air Fair included Jon Melby in his Pitts Super Stinker, Nathan Hammond of GhostWriter Airshows in his de Havilland Canada Super Chipmunk, Karl Gashler and Barry Hancock of Red Thunder Airshows in their two Yak-50s, Leland Kracher and Tom Braymer of the NextGen Eagles Aerobatic Team in their two Christen Eagle IIs, Kyle Franklin of Franklin's Flying Circus and his Piper Super Cub (which included a hilarious comedy act and deadstick landing demonstration!), the Aerial Extreme Skydiving Team, and the Desert Rats Warbird Formation Team and their four Nanchang CJ-6s. This year also marked the first time this air show got a military performer as part of the line-up, with the United States Air Force A-10 Thunderbolt II Demo Team headlining the event; the demo concluded with the United States Air Force Heritage Flight, with Steve Hinton Jr. flying in his father's P-51D Mustang.



Considering that the A-10 Demo Team is based out of Davis-Monthan Air Force Base just a few hours down the road in Tucson, Arizona, it seemed quite appropriate for the team to start their show season in their home state! I was quite excited for the lineup because many of the aforementioned performers are ones I've never seen before. Most notably, this air show served as the debut venue for the NextGen Eagles, which carries on a long-standing air show legacy showcasing the Christen Eagle as an aerobatics platform started by the Eagles Aerobatic Team (1979-1995) and the Iron Eagle Aerobatic Team (1992-2014). And performer Jon Melby is worth mentioning here because being based in Chandler, Arizona, he was with the Buckeye Air Fair from its early days and played a crucial role in helping evolve this event into what it has become today.



One other new element to the 2024 Buckeye Air Fair was the addition of a twilight air show, which took place on Saturday, February 17th. I chose to go out to Buckeye on Saturday and Sunday; I went on Saturday to check out the displays, visit the vendors and exhibitions and even attend a few AOPA seminars, but passed on the twilight air show because I knew photography would be a challenge for me. Plus, there was no daytime air show on Saturday, and it would've made for an extremely long day. I also wanted to spend time in Mesa with my dad and sister while I was in town, so I was happy to go back out the following Sunday morning to attend the regular daytime air show, which as expected was a fantastic start to my 2024 air show season!
